Rules

The Regatta is organized under the authority of Buccaneer Yacht Club, and will be governed by the rules as defined in the *Racing Rules of Sailing 2009-2012* (RRS), the GYA Regulations for Sanctioned Events (available at www.gya.org), and the applicable Fish Class Rules. Specific rules for this regatta are contained in GYA Regulation 40.

Advertising

Advertising will be restricted to Category A (See ISAF Reg 20).

Eligibility and Entry

The GYA Fish Class Championship is open to all GYA General Member Clubs. Notification has been made in accordance with GYA Reg 4.3. Boats will be provided by Buccaneer Yacht Club. Each Club wishing to participate shall return their Application to Compete not later than September 18, 2010. Results of the Competing Clubs Selection will be mailed not later than September 26, 2010 to all Clubs returning Applications.

Racing Area

The racing area will be the waters of Mobile Bay. Courses will be set in the area east of the regatta site.

Courses

The courses will be windward/leeward, triangles, or variations thereof.

Scoring

The Low Point Scoring System (RRS A4) will be used, however no scores shall be excluded. This changes RRS A2. Three races are scheduled, one of which shall be completed to constitute a series. Ties will be resolved in accordance with GYA Regulations for Sanctioned Events 25.2(a). This changes RRS A8.

Prizes

Prizes will be awarded in accordance with GYA Regulations for Sanctioned Events 40.7 and 40.8.
