- Applicant's Club By-laws and/or Constitution. If your Club has yet to adopt By-laws and/or a Constitution, you must include evidence of Incorporation under the laws of the State of your principal place of business;
- Applicant's completed Club Information Survey (below).

**Requested attachment to this application:**

- NOAA Chart of applicant's Race Course area (see Club Information Survey).

**Required actions upon, and subsequent to, GYA approval of this application for GYA Membership:**

- All Applicants: if not a member upon GYA acceptance, your Club agrees to become a member of US SAILING;
- All Applicants: your Club agrees to supply the GYA with one (1) of your Club Burgees;
- All Applicants agree to pay Annual Dues in the amount set by the Board of Directors. Annual Dues are payable as of January 1 of each calendar year, and are delinquent if not received by January 31.

## ARTICLE III – MEMBERSHIP

## SECTION 1: YACHT CLUBS AND SAILING CLUBS

A. ELIGIBILITY REQUIREMENTS – Yacht Clubs and Sailing Clubs located in the States of Alabama, Arkansas, Florida, Louisiana, and Mississippi, and other Southern States as may be determined by the Board of Directors from time to time, not connected with any commercial venture and having a race course separate from those of other organizations, shall be eligible to apply for membership in the GYA in the appropriate classification as described in Paragraph B below and meeting the additional requirements described therein.

## B. CLASSIFICATION

(1) GENERAL MEMBERSHIP – Organizations in this classification shall meet the requirements described in Paragraph A above, and in addition shall have a clubhouse with adequate facilities, and shall be a member of the United States Sailing Association (compliance with this requirement may be delayed until acceptance). General Members shall have the right of full participation in GYA affairs as provided in these Bylaws.

(2) AFFILIATE MEMBERSHIP – Organizations in this classification shall meet the requirements described in paragraph A above, and in addition shall be a member of the United States Sailing Association (compliance with this requirement may be delayed until acceptance). Affiliate Members shall have the right to participate in United States Sailing Association events conducted within the GYA, use the services of the Appeals Committee and the PHRF Rating Committee in accordance with the established procedures, and otherwise participate in GYA affairs on a reduced basis as determined by the Board of Directors from time to time, but shall not be entitled to representation of the Board of Directors.

**Affiliate Member Applicants:** The above GYA By-law III.1.B(2) is correctly interpreted to mean that Affiliate Members shall not be entitled to representation on the Board of Directors and shall not be entitled to vote on Association matters.

**Application Submission:** Applications for Gulf Yachting Association Membership shall be submitted by either the Applicant Club Commodore or Secretary. Please submit application to the Gulf Yachting Association Secretary-Treasurer (p. 5).
