Board Meeting Minutes January 10, 2015 - Biloxi Yacht Club

The annual meeting of the GYA Foundation was called to order at 9:05 A.M. at the Biloxi Yacht Club, Biloxi, Mississippi by Tod Holman, President. Other Board Members present were Chris Luppens, Vice President, Michael Bauer, Treasurer, Michael Mark, Council, John Hirsch, Janet Miller-Schmidt, Secretary and Cynthia Moncrief. Commodore Corky Potts attended the Foundation meeting as a representative of the Executive Committee of the GYA and Jay Smith-Taylor was a guest.

The minutes of the previous annual meeting held in January 2014 were approved as dispersed by motion of John. The minutes posted online December 31, 2014 of the GYA Foundation business matters carried on thorough out the year were approved on a motion of Chris.

Michael Bauer Foundation Treasurer. Gave the financial report. The total of all funds held by the Foundation as of December 31, 2014 was \$158,021.16. Michael told the board he had not made the transfer from the checking account as had been voted at a prior meeting and he will do it promptly. A motion was made to accept the treasurer's report as submitted. The motion carried. In the future Clifford Favort of Delta Financial, New Orleans, LA will be asked to give the board an updated financial report at the next annual meeting.

Michael Bauer made a motion to allow no more than \$6,000.00 in grants be given to those grant application to be approved at this meeting.

The following sailors sent letters and applications requesting funding for regattas throughout the 2014 calendar year of the GYA Foundation and the following grants were given: Randall Richmond, \$495, Clinton Edwards, \$256, Maddie Murray & Amelie Lagarde \$700 each, Frederick Welch \$1,200 (\$700 and \$500 for two different regattas), Pete McGriff \$400, Camillle McGriff, \$400, Michael Burns \$1,849. A motion was made by Tod to approve the grants as described in the total amount of \$6,000. The motion passed.

Old Business: A motion was made by Chris to allow the GYA to post the opinion of the Foundation's Accountant related to acceptable donations with the new IRS Code for a 501-c-3 entity with a disclaimer to protect both the accountant and the foundation. The motion carried.

New Business: A motion by Tod was made to accept Chip MacMillan's resignation from the Foundation effective January 1, 2015. The motion carried. A new Florida Representative will be selected and elected.

He stated that the GYA Board is inclined to discontinue this form of funding in the very near future. A brain storming discussion followed with no definite plan, but each Board member understands the Foundation needs to come up with a new source of income for future growth. Michael Bauer suggested a Foundation Regatta as a possible idea.

There will be an active search for a Florida Representative.

John made a motion the meeting be adjourned at 10:10 A.M. The meeting was adjourned.
